# GROUPAGE AND WAREHOUSE SERVICE CUSTOMS STORAGE, CUSTOMS BROKERS



**Operator of a terminal on 17 000 sq. m. Bonded and free storage in three warehouse buildings on 10 000 sq. m** - solid construction, heated and ventilated, equipped with electronic fire alarm and anti-theft systems.

Situated in the northern industrial area of Sofia, with easy access to E 80 highway, connecting Europe with Turkey, as well as to E 79 highway Europe – Greece.

**Regular groupage cargo lines europewide with local partners, who operate warehouses and perform customs clearance and storage, delivery and collection.**

Warehouse Logistics of Dangerous Substances in specialized store compliant to EC Regulation 1272 / 2008.

Logistical service for hanging garments and textile. A specialized section for hanging garments is available in the warehouse. We also perform quality control of textile.

The transportation of hanging garments is performed on full trailer load and small lot basis with up-to-date, super-cube trailers.

A common customs transit guarantee covers all customs dues and taxes.

Domestic distribution, collection and consolidation of small shipments, incl. ready-made garments from / to any destination.

Multimodal transport and transshipments to and from the Middle East.

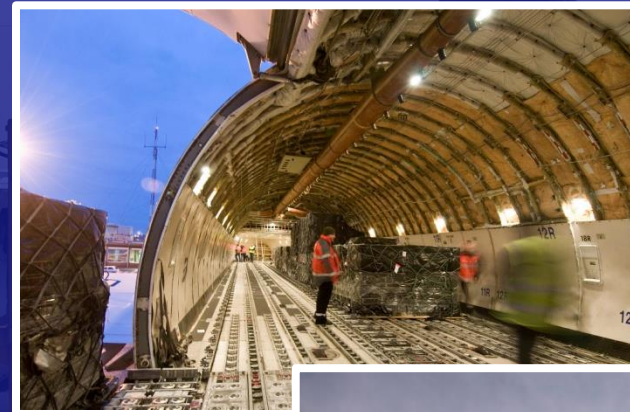
